The risk assessment clearly stated the possible risks of the product not meeting the essential requirements of the regulations and how these had been mitigated using international standards.

The technical file referenced further documents providing technical specifications for the sub-assemblies.

Requirement: descriptions and explanations necessary for the understanding of those drawings and schemes and the operation of the radio equipment;

Descriptions documentation received:

Technical description and operational of the system as well as further descriptions of the associated equipment referring to the block diagrams and schematics of each of the component parts.

A user guide was provided which gave a comprehensive description of setup, components, safety, diagnostics, and how to use the system.

5. Assessment carried out

5.1. Article 6.1a - Health and Safety

The client provided a test report covering H&S requirements for the product which was assessed against EN 62368 as well as an explanation of RF exposure exemption due to the device being low powered (below 20 mW based on EN 62479).

Comprehensive test reports were provided to support the test plan with detailed descriptions of the methodology, test equipment, and test personnel.

5.2. Article 6.1b - EMC

The client provided a test report covering EMC requirements for the product which was assessed against ETSI EN 301 489-3 which is applicable to short range devices such as this product.

There was also testing done against EN 301 489-19 which covers GNSS receivers as applicable for this product.

Comprehensive test reports from an accredited lab were provided to support the test plan with detailed descriptions of the methodology, test equipment, and test personnel.

5.3. Article 6.2 – Spectrum

The client provided a complete set of documentation as required by the Radio Equipment Regulations 2017 for EU-Type Examination for article 6.2.

Harmonised standards were applied during product testing using EN 300 674 parts 1(V1.2.1) and 2-2 (V2.2.1) which cover transport and traffic telematics in the 5.8 GHz band as used by this product. Also EN 303 413 V1.1.1 was applied which is applicable to GNSS receivers as applicable for this product. All versions applied are the latest available.

Comprehensive test reports from an accredited lab were provided to support the test plan with detailed descriptions of the methodology, test equipment, and test personnel.

5.4. Risk assessment review

A risk assessment was provided providing details of how standards have been used to mitigate against the risks highlighted.

6. Assessment conclusions

The DTCO 1381 Rel.4.0e has adequately demonstrated compliance to articles 6.1a, 6.1b and 6.2 of Radio Equipment Regulations 2017.

Continental Automotive GmbH has provided comprehensive documentation to demonstrate how the equipment is intended to be used, technical operation, test procedures and reports, their quality management system, and how international standards have been applied to demonstrate conformity.

The documentation included a risk assessment.
